I am directed to convey you to follow the following procedure for evaluation of Regular 6th semester, 2nd & 4th Re-appear UG classes and special chance examinations:-

1. In view of COVID – 19 it has been decided that the evaluation of the answer scripts for the examinations of Under-graduate classes being conducted w.e.f. 17th August, 2020 shall be held in the colleges concerned. As such, the Principals of the concerned colleges are authorized to evaluate the answer scripts at college level by engaging the eligible teachers of respective colleges. Principals of the colleges are requested to hold the evaluation by strictly maintaining the social distancing and adhering to the guidelines and Standard Operating Procedure issued by the Ministry of HRD, Department of Higher Education vide its Memorandum dated 6th July, 2020 adopted by the Government of Himachal Pradesh University Notification no. 16-18/79-HPU (Genl.) dated 16th July, 2020 which has already been uploaded on the University website.

2. The Principals are, therefore, requested to conduct the evaluation of scripts at their end. The University will depute the persons to collect the awards from the colleges on 25th August, 2020 and thereafter on 2nd September, 2020 as per the list enclosed. The Principals of other colleges will send the awards through post to the Deputy Registrar (Evaluation), Himachal Pradesh University, Shimla – 5. The Principals are also directed to prepare the awards in triplicate, two copies will be forwarded to the University and one copy of the award list will be kept by the colleges for official record. (The format of award list is enclosed herewith which may kindly be

3. In most of the colleges the practicals have already been conducted. In case, if the practicals are not conducted in some of the colleges they shall immediately conduct the practicals after the termination of the examinations by following the Standard Operating Procedure already circulated by the University and the awards may immediately be posted online.

4. The Principals are also directed to mark the attendance subject wise regularly in each session and forward the same to the Deputy Registrar (Exam - 1) to avoid the confusion of appearance in the exams as in the absence of the attendance it becomes very difficult to settle the results of the students.

UMC All the UMC cases be sent under registered post in separate cover to Smt. Meena Kumari, Section Officer (UMC), H.P. University, Shimla-5.

Stray Cases. All stray cases in respect of the Examinees of your centre be promptly sent properly under a separate cover to Smt. Asha Devi Deputy Registrar (Exam-I) H.P.University, Shimla-5.

In addition to above, the examinations of some other professional courses/Bachelor degree like BBA, BCA, BFA, BTTM, BALLB, BPE, BPED are also being held which are being run by the colleges with guest faculty. As per past practice, the answer-scripts of these classes may be dispatched to Sh. Prem Raj Sharma (S.O.), H.P. University, Shimla-5 on same day. Further, the detail of the regular teachers posted in respective colleges i.e. (i) Name of the teacher (ii) Date of regular appointment (iii) Name of the course being taught, may be supplied at the earliest.

Further, the special chance examinations are also being held in three centres i.e. G.C. Baroh, G.C. Sugh Bhatoli and G.C. Khundian. Therefore, the concerned principals of these colleges should ensure to get answer-scripts of this examination evaluated as per above instructions. The awards of the same may be sent separately.
